

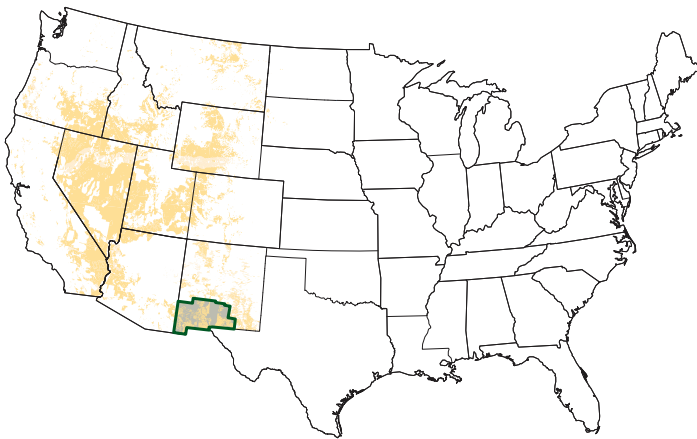

WATER AND UTILITIES PROJECT

Purpose and Need: The five Starvation Draw dams no longer support the resource management program. The dams will be removed and retrofitted with grade control structures to allow wider and natural channel flow. This project will include the hydrology and hydraulic analysis, assessment of downstream flood risk, and design of the grade control structures.

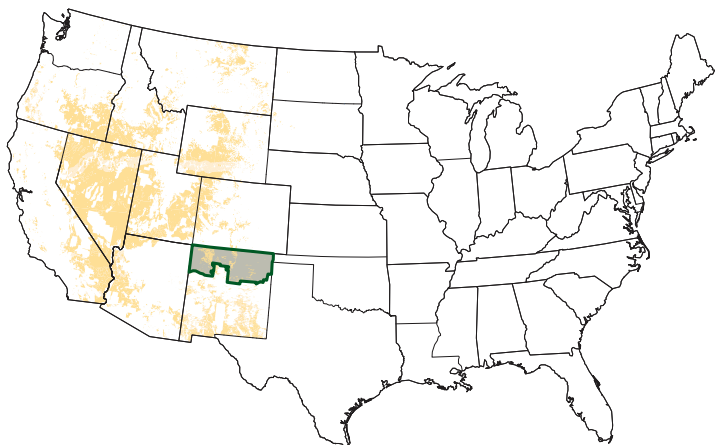

Year Constructed or Established: In the 1960s, with subsequent repairs and paving; most recent pavement overlay in 2003

Recreational Opportunities: On and off-road biking, hiking, fishing, camping, sightseeing, and bird watching



Annual Visitation: 10,500

District or Unit Name: Farmington District

TRANSPORTATION PROJECT

Purpose and Need: The Wild Rivers Backcountry Byway provides the sole access to the Wild Rivers Recreation Area and the stunning scenery of the Rio Grande Gorge National Monument. This project will extend the life of the road by constructing an asphalt overlay on the deteriorating pavement as well as establish a dedicated bike lane to improve the safety of bikers riding the road.

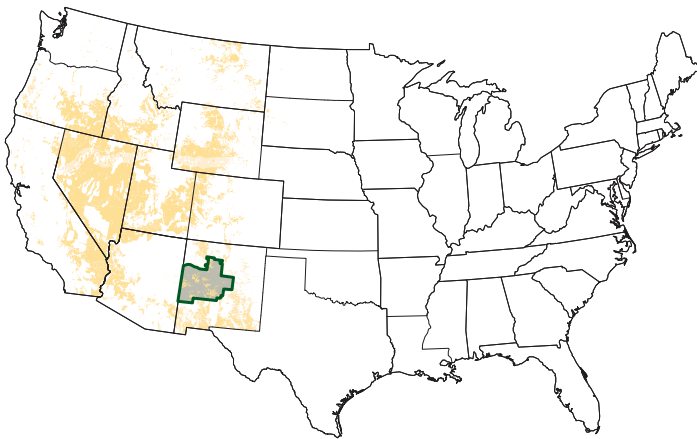

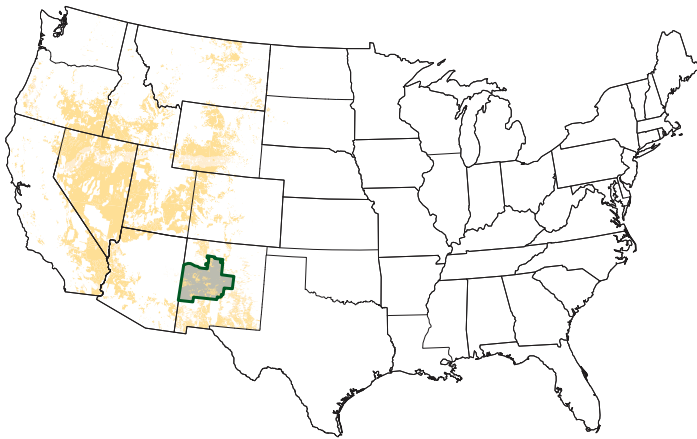

District or Unit Name: Albuquerque District

BUILDING AND STRUCTURES PROJECT



Purpose and Need: The facilities are dilapidated and need to be replaced as safety concerns rise with increasing use. In addition, access to the facilities is not in compliance with ADA accessibility requirements. This project will bring the site into compliance with ADA and ABA requirements and eliminate safety hazards that pose a threat to the visiting public.

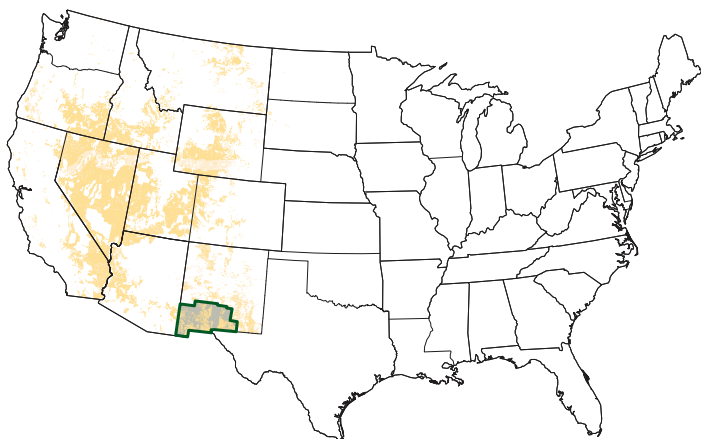

WATER AND UTILITIES PROJECT

Purpose and Need: This project will repair the Apache Dam, which was built for irrigation and flood control purposes. This dam requires downstream embankment repairs following a recent overtopping event. The primary outlet requires a new trashrack to stop clogging and concrete repairs at the outlet and the secondary spillway.

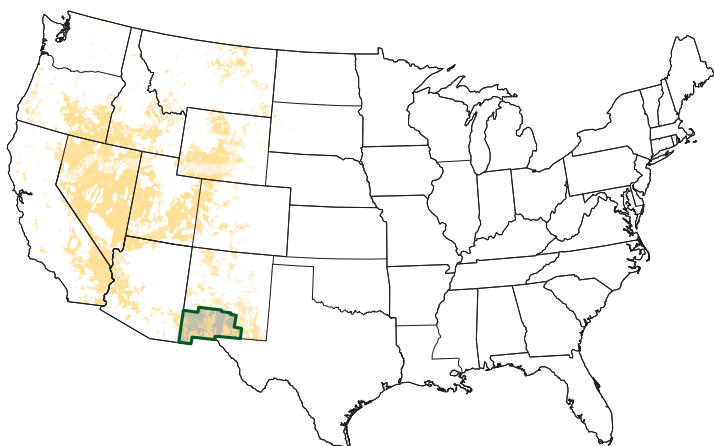

Year Constructed or Established: 2009 (Prehistoric Trackways National Monument)

Recreational Opportunities: Viewing trackway fossils, hiking, horseback riding, and off-highway vehicle use



Annual Visitation: 43,194

District or Unit Name: Las Cruces District

TRANSPORTATION PROJECT

Purpose and Need: This project will repair safety issues with the primary access road into the Prehistoric Trackways National Monument. This project will reconstruct an aggregate road surface and harden the arroyo crossings to ensure safe public access by buses and passenger vehicles. Failure to improve the road will result in further degradation and increased cost for future repairs. Continued loss of access across the arroyo crossings can jeopardize the safety of members of the public, leaving them unable to exit the trailhead after heavy rainstorms.

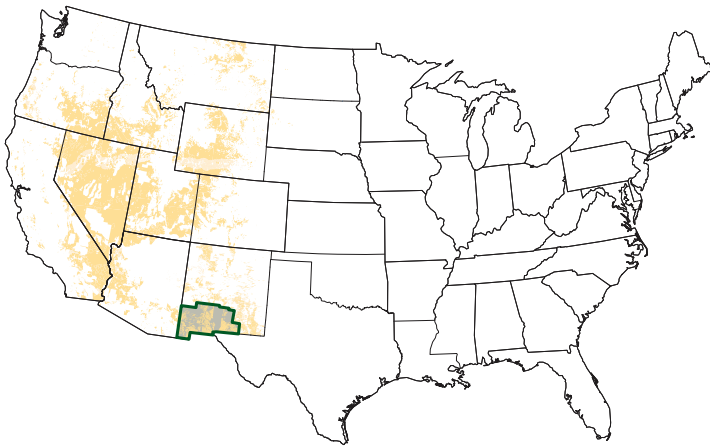

TRANSPORTATION PROJECT



Purpose and Need: The Caballo and Cooke's Roads are natural surface roads that provide access to radio and cell towers for multiple government agencies and private companies and also provide recreation access. The roads require embankment rebuilding where erosion has occurred and repair to the armoring of culverts and arroyo crossings to prevent road failure and closure, which would negatively impact all access.

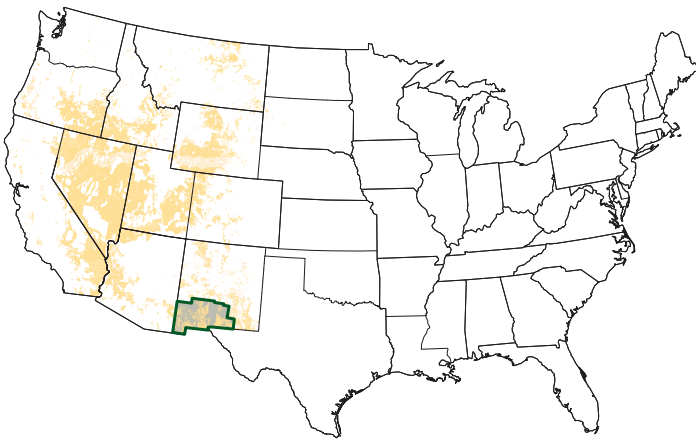

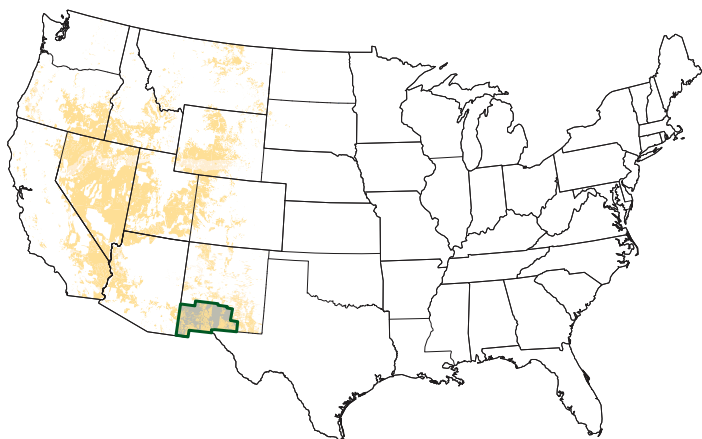

BUILDING AND STRUCTURES PROJECT



Purpose and Need: Lake Valley Historic Townsite provides visitors the opportunity to learn about life in the historic mining town in 1878. This project will repair the host site, replace fencing, provide site grading improvements, and repair site trails to make the site safer and more stable for the public to walk around the historic structures. Regrading work will mitigate erosion around the site to reduce impacts on the buildings and reduce annual maintenance costs.
